

HRSA SCHOLARSHIPS FOR DISADVANTAGED STUDENTS (SDS) APPLICATION FOR MASTER OF SOCIAL WORK (MSW) 2019-20 ACADEMIC YEAR

Overview

The Scholarships for Disadvantaged Students (SDS) program provides \$650,000 in annual scholarships to full-time, financially needy students from disadvantaged backgrounds, enrolled in a Master of Social Work (MSW) program at Long Island University. The maximum award in SDS funds is **\$30,000** per academic year and is renewable if funds are available and program criteria are met. Applicants should be advised that student loans may be reduced to accommodate SDS awards. Awards can be applied to Summer, Fall, and/or Spring terms. No financial aid awards may exceed the estimated cost of attendance. Eligibility for an award does not guarantee a scholarship, as funding is limited.

Eligibility Requirements

To be eligible, you **must** have financial need and come from either an economically or environmentally disadvantaged background. **Priority will be given to students who are not eligible for other University awards and program discounts.**

Economically Disadvantaged: defined as an individual that comes from a family with an annual income below a level based on low-income thresholds according to family size published by the U.S. Census Bureau, adjusted annually for changes in the Consumer Price Index.

Environmentally disadvantaged: defined as an individual who comes from an environment that has inhibited the individual from obtaining the knowledge, skills, and abilities required to enroll in and graduate from a health professions school, or from a program providing education or training in an allied health profession. LIU will consider applicants who meet **one or more** of the following criteria to be from an environmentally disadvantaged community.

- First generation college student
- Graduated from a high school with low ACT/SAT scores based on most recent data available
- Graduated from a high school from which, based on most recent data available:
 - low percentage of seniors receive a high school diploma; or
 - low percentage of graduates go to college during the first year after graduation
- Graduated from a high school with low per capita funding
- Graduated from a high school at which, based on most recent data available, many of the enrolled students are eligible for free or reduced price lunches
- The individual comes from a family that receives public assistance (e.g., Aid to Families with Dependent Children, food stamps, Medicaid, public housing)
- The individual comes from a hometown county that is designated under section 332 of the Act as a health professional shortage area by HRSA

Application Requirements:

- Students must complete the Free Application for Federal Student Aid (FAFSA) at fasfa.gov. The parental income will be used to determine a student's eligibility for *economically disadvantaged* in all cases except when the student is considered independent (at least 24 years old and not listed as a dependent on parents' Federal income tax for three (3) or more years). Dependent applicants must complete the "parental income section."
- Students must submit **three (3) years** of their and their parents' Federal tax returns and/or statements from the IRS that he or she was not required to file taxes. Students must also report their own, spouse's, and/or parent's assets and other resources, such as *trust funds or family member support*.
- Students must provide documentation of their age.
- Students must be a citizen, national, or lawful permanent resident of the United States.
- Students must be enrolled full time (e.g., **9+ credits per term**) in a graduate master of social work degree program at either the LIU Brooklyn or Post campus.
- Students must make satisfactory academic progress in accordance with University policy as published in the LIU graduate bulletins.

Application Procedures:

Please keep application and all pages together as one (1) document. Send original pages of application and forms to address listed below. All applications received will be date and time stamped. Applications will be processed in the order of receipt. **Incomplete applications and forms will not be processed.** If the applicant's application is incomplete or the applicant is determined ineligible for SDS, you will be notified via your MyLIU student email account. Students must file application by **July 15, 2019 and be registered for Fall 2019 classes** in order to be considered for funding during 2019-2020 academic year. Please note that funds are disbursed according to eligibility and availability; once those funds are exhausted, any pending applications, even for eligible students who have applied within the appropriate time frame, will not be funded.
